FROM THE PRESIDENT

J. Foster Watkins President, Gainesville College

As reflected in the photograph in this issue of Anchors Away, construction of our Continuing Education/Public Service Building is underway. Personnel from Carlson Construction Company of Marietta moved on site on June 1, and then the "rains came." They accrued almost 30 rain days before they were able to get underway in a meaningful way. Mr. Howington, Mr. Pardue, and I were amazingly surprised on "picture-taking day" to assess their progress once they got started. The early projection is that the major steel work of the building will be in place as we begin school this fall with the anticipated use of the building scheduled for fall, 1990. I am sure that the construction process will create a lot of excitement among students as they return in the fall and will be a source of conversation during the year.

The College's efforts with the new building were not the only construction-related projects underway at the institution during the summer. As a means of dealing with the anticipated 2300 + students during the fall quarter, seven portable buildings were brought to campus and located "conspicuously by conveniently" between the Academic Building and the Library. These facilities will provide three general classrooms, a specialized classroom for physical education, and 12 needed offices for a growing faculty and staff.

Final architectectural work has been completed and bids are being taken to enclose the courtyard in the Math/Science Building which will provide two general classrooms, a physics lab, and five office spaces. This construction will be underway during the fall quarter with completion anticipated before January 1.

Finally, the institution is making a strong appeal to have the second phase of the Academic Building included on the short list of capital projects which will be submitted to the Legislature next year; to secure funding to support another addition to the Music/Art Building which will allow that facility to more adequately handle our growing fine and performing arts program; and to secure increased repairs and renovations funding which will enable us to deal with facilities problems which are approaching crisis stages, particularly with respect to the leaking swimming pool and the need to reroof a number of buildings on campus. Parenthetically, we are reminded in more ways than one that the institution is celebrating the 25th anniversary year of its founding. We remain optimistic that, as one of the fastest growing institutions in the University System, the institution will benefit as the Legislature through the Board of Regents responds to these multiple needs.

We were pleased with the response received to the Alumni Survey which was a joint effort of the Collège and the Alumni Association last spring. The response percentage which approached 40 percent was strong for that type of survey and reflects positively on the College as perceived by its alumni. Preliminary analyses of the responses are being utilized on campus as we continue to try to strengthen the institution's abilities to meet the needs of the full range of students it serves. More detailed attention to the results of the survey will be addressed in this column in subsequent editions of Anchors Away.

In closing, I would like to call your attention to two very encouraging responses. In excess of 99 percent of the respondents indicated that they had recommended or would recommend Gainesville College to others, and in excess of 95 percent of the responding alumni indicated that the College had generally met their expectations. While the nature of the responses to the specific items on the survey was generally positive, the data as analyzed to this point do contain constructive feedback which is being considered by appropriate parties with respect to our continuing responsibilities to improve the institution. We were particularly pleased with the opportunity taken by a number of responding alumni to write in constructive suggestions which are being studied in a special way.

We hope to see many of you on campus on November 17 at the culminating activities of the 25th Anniversary celebration.

GC FOUNDATION NEARING \$200,000 GOAL... ALUMNI INCREASING PARTICIPATION

Under the leadership of Andy Walker, 1989 Fund Drive Chairman, the Gainesville College Foundation has received \$190,900 toward the \$200,000 goal. Mini-campaigns are currently being held in Habersham, Jackson, and Forsyth Counties for the second year and in Gwinnett County for the first year.

Two new campaign activities have been targeted directly at GC alumni. Eleven members of the Foundation Board of Trustees are alumni of Gainesville College. This group, led by Rich White, Chairman of the Foundation and member of the GC Class of '71, feels it is time for the alumni to join area businesses and friends of the College in contributing funds to support scholarships and other activities not provided by state tax dollars.

Many of you received an appeal letter from this group of alumni trustees. As of September 5, TWENTY-SIX ALUMNI HAD RESPONDED, SENDING GIFTS TOTALING \$1,165.

An alumni phonathon was held in Gainesville/Hall County during which fifty-one alumni volunteers made calls over a three-night period. The results...

819 calls attempted 426 completed 120 addresses and names updated 114 GIFTS RECEIVED TOTALING \$3,205.


